**ORDER APPROVING
TARIFF REVISIONS

On December 3, 2013, the Public Utilities Commission (Commission) received an application from Broadvox-CLEC, LLC (Broadvox). This filing proposes to modify language in its South Dakota Access Services Tariff No. 1.

On December 5, 2013, the Commission electronically transmitted notice of the filing and the intervention deadline of December 20, 2013, to interested individuals and entities. On December 20, 2013, a Petition of AT&T Corp. to Intervene and Request to Suspend Tariff and Investigate was filed with the Commission. On January 24, 2014, Broadvox filed its Answer of Broadvox-CLEC, LLC to AT&T Corp.'s Petition to Intervene and Request to Suspend Tariff and Investigate. Broadvox also filed its response to Commission staff's data request. On February 3, 2014, the Commission issued an Order Granting Intervention and Suspending Tariff. On February 7, 2014, Broadvox filed revised tariff pages.
