On April 1, 2015, the South Dakota Public Utilities Commission (Commission) received filing from Qwest Corporation d/b/a CenturyLink QC requesting approval of revisions to its South Dakota Access Service Tariff. These revisions change the Intrastate Nonrecurring USOC for the Expedite Order Charge and update tariff references to the CenturyLink Operating Companies Tariff F.C.C. No. 11. Rates and terms will not be impacted.

On April 2, 2015, the Commission electronically transmitted notice of the filing and the intervention deadline of April 17, 2015, to interested individuals and entities. No parties sought intervention.
