On February 21, 2017, the South Dakota Public Utilities Commission (Commission) received a filing from Qwest Corporation dba CenturyLink (CenturyLink) requesting a waiver of the utilization threshold requirements outlined in Federal Communications Commission's (FCC's) Number Resource Optimization Orders, FCC 00-429 and FCC 01-362 released in CC Docket No. 99-200, which would allow PA/NeuStar, the Number Pooling Administrator, to open a new Code of 10,000 consecutive numbers in the 605-XX4, 605-XX5, 605-XX6 or 605-XX7 NPA in the Sioux Falls Rate Center.

The Federal Communications Commission (FCC) allows state commissions to grant a waiver of the rules if a carrier has demonstrated a verifiable need for numbering resources. The waiver process is referred to as the "safety valve" process.<sup>1</sup>

On February 23, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of February 27, 2017, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and 47 C.F.R. § 52.15(g)(4).

At its regularly scheduled meeting of February 28, 2017, the Commission considered this matter. The Commission voted unanimously to grant the waiver of the utilization threshold requirement in the Sioux Falls, South Dakota rate center, with the condition CenturyLink provides the Commission a utilization report regarding this code of 10,000 numbers in two years. It is therefore

ORDERED, that the waiver of utilization threshold requirement in the Sioux Falls, South Dakota rate center is granted, with the condition CenturyLink provides the Commission a utilization report regarding this code of 10,000 numbers in two years.
