On May 15, 2017, the South Dakota Public Utilities Commission (Commission) received a filing from Broadvox-CLEC, LLC (Broadvox) requesting approval of revisions to its Tariff No. 1, Pages No. 1, 60, 61, 62, and 63. The proposed tariff revision filing is done to update several of the Switched Access diagrams and the accompanying language. Broadvox requests an effective date of March 15, 2017.

On March 16, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of March 31, 2017, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention.
