ORDER GRANTING WAIVER
AND CERTIFICATION

On June 9, 2017, the Public Utilities Commission (Commission) received an application from Northeast Nebraska Telephone Company (Company) requesting the Commission grant a waiver of the Commission's ETC filing requirements pursuant to ARSD 20:10:32:56, on the grounds that the reporting requirements are unduly burdensome, as the Company will seek certification from the Nebraska Public Service Commission. The purpose of this filing was to provide information constituting the Company's plan for the use of its federal universal service support and to otherwise verify that the Company will use all federal universal service support received in a manner that is consistent with the federal universal service provisions of 47 U.S.C. § 254. Pursuant to 47 C.F.R. § 54.314(a), in order for an eligible telecommunications carrier (ETC) to receive support pursuant to the Federal Communications Commission's (FCC's) high-cost program, a state must file an annual certification with the Universal Service Administrative Company (USAC) and the FCC stating that all federal high-cost support provided to the ETC "was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended." On June 21, 2017, the Company responded to Staff's data request.

On June 15, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of June 30, 2017, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of July 5, 2017, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31 and 47 U.S.C. § 254. The Commission unanimously voted to grant a one-year waiver pursuant to ARSD 20:10:32:56, finding that compliance with the certification requirements is unduly burdensome and unnecessary given that the information would be duplicative of what the Company files in Nebraska. The Commission unanimously voted to approve the Company's request for certification. The Commission finds that the Company is eligible to receive federal support. The Commission finds that all federal high-cost support provided to the Company was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended. It is therefore

ORDERED, that a one-year waiver pursuant to ARSD 20:10:32:56 is hereby granted. It is further

ORDERED, that the Company is eligible to receive federal support as all federal high-cost support provided to the Company was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended. It is further

ORDERED, that the Commission approves the Company's request for certification.
