On June 9, 2017, the South Dakota Public Utilities Commission (Commission) received a filing from Airus, Inc. (Airus) requesting approval of revisions to its Access Service Tariff No. 1. Airus is submitting this filing to be in compliance with the Federal Communications Commission's, November 11, 2011, Intercarrier Compensation Reform Order (FCC 11-161). Airus requests that the tariff revisions become effective on July 31, 2017. Airus later requested an effective date of July 29, 2017.

On June 15, 2017, the Commission electronically transmitted notice of the filing and the intervention deadline of June 30, 2017, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No parties sought intervention. On June 29, 2017, Airus filed revised tariff pages.

The Commission voted unanimously to approve the requested revisions to Airus' South Dakota Tariff No. 1 effective July 29, 2017. It is therefore

ORDERED, that the Commission approves the above-referenced revisions to Airus' South Dakota Tariff No. 1, with an effective date of July 29, 2017.
