ORDER APPROVING 2020 ENERGY EFFICIENCY PLAN STATUS REPORT; FINANCIAL INCENTIVE; AND ENERGY EFFICIENCY ADJUSTMENT RIDER

On May 3, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from Otter Tail Power Company (Otter Tail) requesting approval of its 2020 Energy Efficiency Plan (EEP) Status Report and 2021 Annual Filing to Update the Energy Efficiency Adjustment Rider. Specifically, Otter Tail requests that the Commission approve its 2020 Status Report, the 2020 financial incentive of \$209,700, and its proposal that the Energy Efficiency Adjustment Factor remain at \$0.00195/kWh for July 2021 through June 2022.

On May 6, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of May 21, 2021, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed. On June 11, 2021, Otter Tail filed responses to Commission staff's data requests. On June 15, 2021, Commission staff filed a Memorandum regarding its recommendation in this matter.

The Commission has jurisdiction over this matter pursuant to SDCL 49-34A, specifically, 49-34A-6, 49-34A-8, and 49-34A-8.2.

At the Commission's regularly scheduled meeting on June 22, 2021, the Commission considered this matter. Commission staff recommended approval of 1) Otter Tail's 2020 financial incentive of \$209,700; 2) Otter Tail's 2020 Energy Efficiency Plan Status Report, and 3) the request that the Energy Efficiency Adjustment Factor remain at \$0.00195/kWh for July 2021 through June 2022. Finding that Otter Tail's request for approval of its 2020 financial incentive, 2020 EEP Status Report, and unchanged Energy Efficiency Adjustment Factor is just and reasonable, the Commission voted unanimously to approve Otter Tail's request. It is therefore

ORDERED, that Otter Tail's 2020 EEP Status Report, the 2020 financial incentive of \$209,700, and the proposal that the Energy Efficiency Adjustment Factor remain at \$0.00195/kWh for July 2021 through June 2022, are hereby approved.
