Senate Bill 61, passed during the 2010 Legislative Session, requires each electric utility to file with the Commission its minimum rate for purchases of electricity generated by a small renewable power facility with a capacity of one hundred kilowatts or less. SDCL 49-34A-108.

East River and the East River members listed above have assigned our obligations under the Public Utility Regulatory Policies Act of 1978 to Basin Electric Power Cooperative. For a qualifying customer-owned small renewable power facility, and subject to certain adjustments and conditions as well as compliance with interconnection and safety requirements, the East River members listed above would pay, the following rates for the calendar year 2026:

**If between 50 kW to 150 kW**

Within Midcontinent Independent System Operator (MISO):	\$ 0.01980 per kWh*
Within Southwest Power Pool (SPP):	\$ 0.01930 per kWh*

\*Or Real Time Hourly Locational Marginal Pricing (LMP)

**If greater than 150 kW**

Real Time Hourly Locational Marginal Pricing (LMP)
