**ORDER GRANTING  
INTERVENTION**

On May 5, 2014, Prelude, L.L.C. (Prelude) filed a Complaint against Basin Electric Power Cooperative (Basin), Butte Electric Cooperative, Inc., Grand Electric Cooperative, Inc., Moreau-Grand Electric Cooperative, Inc., Rosebud Electric Cooperative, Inc., and Rushmore Electric Power Cooperative, Inc. (Respondents) with the South Dakota Public Utilities Commission (Commission). Prelude has projects located in Respondents' service territories. Prelude alleges that Respondents have failed to enter into good faith negotiations of long term electric power purchase agreements pursuant to the Public Utility Regulatory Policy Act of 1978. On May 8, 2014, the Commission electronically transmitted notice of the filing and the intervention deadline of May 27, 2014, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv.

On May 23, 2014, the Commission received a Petition to Intervene from South Dakota Electric Utility Companies (SDEUC). On May 29, 2014, the Commission received a Motion to Dismiss from Basin. The Commission has jurisdiction to grant intervention to interested parties in a proceeding pursuant to SDCL 1-26-17.1 and ARSD 20:10:01:15.02 through 20:10:01:15.05.

At its regularly scheduled meeting on June 10, 2014, the Commission considered whether to grant intervention to SDEUC. The Commission voted unanimously to grant intervention. It is therefore

ORDERED, that the South Dakota Electric Utility Companies' Petition to Intervene is granted.
