ELIGIBILITY AND FACTOR UPDATE)	

On October 1, 2015, the South Dakota Public Utilities Commission (Commission) received a petition from Northern States Power Company dba Xcel Energy (Xcel) for approval of its 2016 Infrastructure Rider project eligibility, revised adjustment factor, and tracker account report. Xcel requests approval of project eligibility for 10 projects included in the Docket EL14-058 Settlement Agreement Exhibit C not already included in the rider; project eligibility of 12 additional projects; the Infrastructure Rider Tracker Report and true-up for the 2015 revenue requirements of approved project investment and the proposed newly added projects; 2016 Infrastructure Rider revenue requirements of \$10.3 million; an updated Infrastructure Rider Adjustment Factor of \$0.004854 per kWh; a proposed revision to the Infrastructure Rider tariff sheet; and a proposed customer notice. Xcel proposes a January 1, 2016, effective date. Xcel states the average bill impact for a residential customer using 750 kWh per month will be increased to \$3.64 per month, compared to the current average residential bill impact of \$0.59 per month under the current rate.

On October 8, 2015, the Commission electronically transmitted notice of the filing and the intervention deadline of October 23, 2015, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. The Commission has jurisdiction in this matter pursuant to SDCL 49-34A-73 through 49-34A-78.

SDCL 49-34A-77 requires an electric utility filing an application for a phase in rate plan to pay a filing fee to be determined by the Commission in an amount not to exceed two hundred fifty thousand dollars (\$250,000), to defray Commission expenses incident to analyzing and ruling upon this type of filing.

At its regularly scheduled meeting on October 13, 2015, the Commission considered this matter. The Commission voted unanimously to assess Xcel a filing fee as requested by Commission Staff up to the statutory limit of \$250,000 to account for actual expenses incurred in review of this filing commencing from the filing date. It is therefore

ORDERED, that Xcel shall be assessed a filing fee pursuant to SDCL 49-34A-77 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$250,000.
