On April 12, 2019, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) that included the company's 2018 Energy Efficiency Plan Annual Report and reconciliation of the company's Energy Efficiency Plan cost recoveries for the 2018 calendar year. Further, MidAmerican requested approval of its 2019 Energy Efficiency Cost Recovery Factors that account for the 2018 reconciliation amounts, the 2018 performance incentive, and the 2019 Energy Efficiency Plan budget approved by the Commission in docket GE17-002. MidAmerican requested an effective date of May 31, 2019, for the Energy Efficiency Cost Recovery Factors and accompanying tariff sheets. The requested tariff sheet revisions for the 2019 EECR rates are as follows:

## South Dakota Electric Tariff Schedule No. 2

SD P.U.C. Sec. No. 3 4<sup>th</sup> Revised Sheet No. 80

Canceling 3rd Revised Sheet No. 80

South Dakota Gas Tariff Schedule No. 2

SD P.U.C. Sec. No. 3 6<sup>th</sup> Revised Sheet No. 72

Canceling 5th Revised Sheet No. 72

On April 18, 2019, the Commission electronically transmitted notice of the filing and the intervention deadline of May 3, 2019, to interested individuals and entities on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were received. On April 29, 2019, MidAmerican responded to staff's data requests. On May 23, 2019 Staff filled its Memorandum and Recommendation.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-6, 49-34A-8, 49-34A-8.2, 49-34A-8.4, 49-34A-10, 49-34A-11, and 49-34A-12.

At its regularly scheduled meeting on May 28, 2019, this matter came before the Commission for consideration and action. Staff recommended that the Commission approve MidAmerican's 2018 cost recovery reconciliation, 2018 performance incentive, proposed EECR rates, and instructing MidAmerican to file a supplemental filing in the docket as described in its Memorandum. Finding that MidAmerican's 2018 cost recovery reconciliation, 2018 performance incentive, and proposed EECR rates to be just and reasonable, the Commission voted unanimously to approve the 2018 reconciliation, 2018 performance incentive, and proposed EECR rates.

It is therefore

ORDERED, that MidAmerican's 2018 performance incentive and 2018 reconciliation are approved. It is further

ORDERED, that MidAmerican shall file a supplemental filing as described by MidAmerican during the meeting.

ORDERED, that the revised EECR rates and associated tariff sheet, as set forth above, are approved with an effective date of May 31, 2019.
