The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, and 49-34A-10 and ARSD Chapter 20:10:13.

At its regularly scheduled meeting on September 3, 2019, the Commission considered this matter. Commission staff recommended approval of the Customer Reference Guide and tariff revisions with an October 1, 2019, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the Customer Reference Guide and tariff revisions, effective October 1, 2019.

It is therefore

ORDERED, that MDU's request for approval of its Customer Reference Guide and to revise its aforementioned tariff sheets is hereby granted and the revisions are approved, effective for services rendered on and after October 1, 2019.
