On April 15, 2020, the South Dakota Public Utilities Commission received a filing from MidAmerican Energy Company (MidAmerican) that included the company's 2019 Energy Efficiency Plan Annual Report. On June 30, 2020, MidAmerican filed its reconciliation of the company's Energy Efficiency Plan cost recoveries for the 2019 calendar year. Further, MidAmerican requested approval of its 2020 Energy Efficiency Cost Recovery Factors that account for the 2019 reconciliation amounts and the 2019 performance incentive. MidAmerican requested an effective date of July 30, 2020, for the Energy Efficiency Cost Recovery Factors and accompanying tariff sheets.

On April 16, 2020, the Commission electronically transmitted notice of the filing and the intervention deadline of May 1, 2020, to interested entities and persons on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were filed.

The revised tariff sheets revisions are as follows:

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-6, 49-34A-8, 49-34A-8.2, 49-34A-8.4, 49-34A-10, 49-34A-11, and 49-34A-12.

At its regularly scheduled meeting on July 23, 2020, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a July 30, 2020, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the 2019 reconciliation, 2019 fixed percentage performance incentive, and proposed tariff revisions, effective July 30, 2020.

It is therefore

ORDERED, that MidAmerican's 2019 fixed percentage performance incentive and 2019 reconciliation amounts are hereby approved. It is further

ORDERED, that the gas and electric Energy Efficiency Cost Recovery Factors and associated tariff sheets, as set forth above, are hereby approved with an effective date of July 30, 2020.
