ORDER APPROVING  
TARIFF REVISIONS

On May 8, 2013, the South Dakota Public Utilities Commission (Commission) received a filing from OrbitCom, Inc. (OrbitCom). This filing proposes to modify OrbitCom's switched exchange access tariff, Tariff No. 2, to comply with the Federal Communications Commission's (FCC) Intercarrier Compensation Reform Order, the November 18, 2011, Report and Order and Further Notice of Proposed Rulemaking, in WC Docket No. 10-90, et al., FCC 11-161 by reducing rates to at or below that of the RBOC. OrbitCom seeks an effective date of July 1, 2013. On June 10, June 27, and July 30, 2013, OrbitCom filed its responses to staff's data requests. On May 9, 2013, the Commission electronically transmitted notice of the filing and the intervention deadline of May 24, 2013, to interested individuals and entities. No parties sought intervention.

At its regularly scheduled meeting of August 27, 2013, the Commission considered this matter. The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-31. The Commission voted unanimously to approve the requested revisions to OrbitCom's South Dakota Tariff No. 2, with revisions as noted at the meeting. On September 6, 2013 and September 9, 2013, revised tariff pages were filed. It is therefore

ORDERED, that the Commission approves the above-referenced revisions to OrbitCom's South Dakota Tariff No. 2 effective as of July 1, 2013.
