- Drug and Alcohol Program inspections
- PHMSA Inadequate Rating for Excavation Damage Enforcement- 811 Board of Director's responsibility but affects funding for Pipeline Safety
- Excavation Damages

2025 Inspections

- Public Awareness Inspection
- Standard Records Inspection
- Standard Field Inspection (valves, cathodic protection, above ground pipe, and pipeline markers)
- Control Room Management for MidAmerican Energy and Montana Dakota Utilities
- O&M Manual Review for Montana Dakota Utilities and NorthWestern Energy Transmission

Upcoming Projects and Areas of Focus in South Dakota

- Additional RNG Facilities getting installed
- ► New transmission line to soybean facility by Mitchell
- ▶ Relocation of transmission line due to highway project
- Continuous growth in new residential and commercial construction
