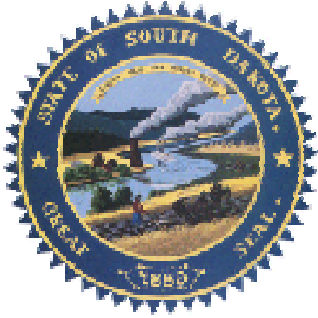

The Commissioners and Staff are available for discussion on the topics contained in this report.

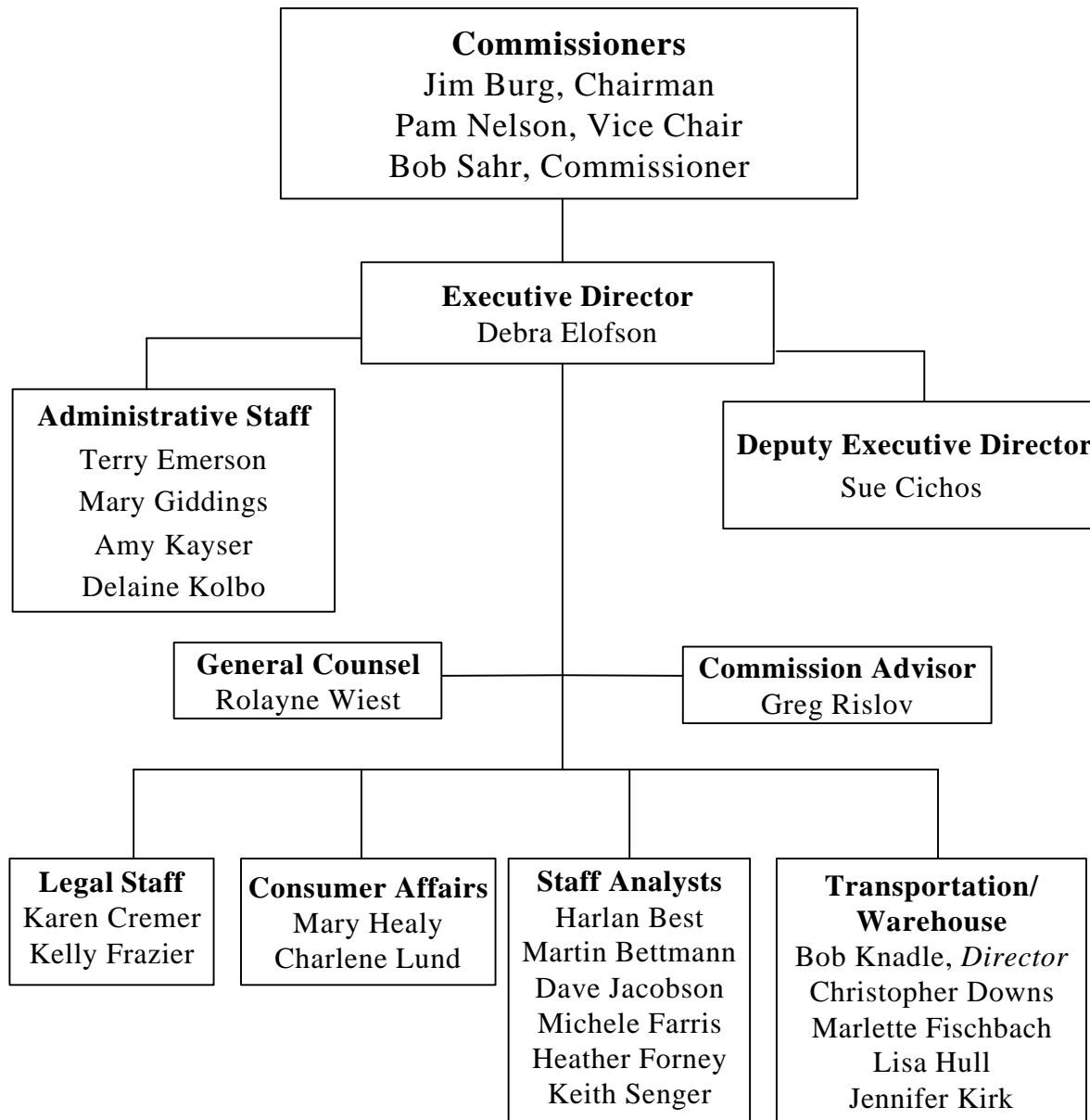

The Gross Receipts Tax Fund Revenues fund entirely and exclusively the Commission's Fixed Utility Division.

2001 Highlights and activities

BACKGROUND

The South Dakota Public Utilities Commission consists of three elected at-large Commissioners each serving staggered, 6-year terms. In addition, the Commission has 23 staff members. The Commission is authorized by statute and regulates the rates and service quality of investor-owned electric, natural gas, and telephone utilities and has territorial jurisdiction over all retail electric utilities, including cooperatives, independents and municipals; it registers interstate motor carriers; it licenses and inspects grain elevators and grain dealers; it operates the natural gas pipeline safety program; and it has administrative responsibility for the state's one-call notification program which regulates excavation activities. The Commission also handles consumer complaints involving the service quality of all the referenced industries.

APPOINTMENT

On December 31, 2001, Bob Sahr of Pierre was sworn in as a member of the South Dakota Public Utilities Commission. Sahr, 35, filled the vacancy left earlier this year by the death of long-time Commissioner Laska Schoenfelder. Sahr, a native of Pierre, was legal counsel for the state of South Dakota Bureau of Personnel. He holds a bachelor of science degree in business and a law degree, both from the University of Colorado.

GAS AND ELECTRIC

On May 24, 2001, in a unanimous ruling, the South Dakota Supreme Court affirmed the decision of the SDPUC to stop Northern States Power - now Xcel Energy - from passing along the cost of burying overhead lines in downtown Sioux Falls to all of its Sioux Falls customers. The decision reversed a ruling from the Sixth Judicial Circuit. The Commission had first ruled on the matter in March of 2000, after determining NSP had incorrectly found all Sioux Falls customers benefited. The one-time charge appeared on November 1999 statements as a "Facility Surcharge 10/28" with the notation, "Your electric bill this month includes a one-time surcharge for special electrical facilities by the City of Sioux Falls. The surcharge recovers the additional cost incurred above NSP's standard costs." Sioux Falls city officials said NSP asked the city to cover the cost, and the city refused.

On September 24, 2001, MidAmerican Energy Company filed an application with the PUC for a general rate increase to natural gas distribution rates of \$3,697,000 or approximately 5.6%. The company stated that the primary reasons for the increase were inflation, and the expansion and upgrading of its distribution system in the fast growing Sioux Falls area. It had been approximately 3 years since MidAmerican filed the last general rate increase filing. The Commission suspended the proposed effective date of the increase and had until March 24, 2002, to issue a decision before suspension authority expired and rates took effect. Staff testimony was due January 23, 2002, and a hearing in this matter was scheduled to commence February 20, 2002.

TELECOMMUNICATIONS

On July 27, 2001, Qwest Corporation filed a Petition for Initiation of Cost Docket to Determine Prices for Unbundled Network Elements in Qwest's Statement of Generally Available Terms (SGAT). On September 14, 2001, intervention was granted to AT&T Communications of the Midwest, Inc. and to Midcontinent Communications. TC01-098

On October 25, 2001, Qwest Corporation filed with the SDPUC a Petition for Recommendation that the Federal Communications Commission Grant Qwest Entry into the In-Region InterLATA Market Under Section 271 of the Telecommunications Act of 1996. Intervention was granted to Black Hills FiberCom, LLC, Midcontinent Communications, and AT&T Communications of the Midwest, Inc. on December 5, 2001. A Procedural Schedule was issued December 18, 2001, setting January 18, 2002, as the date that Staff and Intervenors identify disputed issues (except for issues relating to the final OSS report which had not yet been issued); a prehearing conference was held on February 7, 2002; Staff and Intervenors' testimony was due March 18, 2002; Qwest had until April 2, 2002 to file rebuttal testimony; and the hearing was scheduled for the week of April 22, 2002. On November 5, 2001, Qwest Corporation filed a Notice of Updated Statement of Generally Available Terms and Conditions with the SDPUC. On November 22, 2000, Qwest filed its original SGAT with the SDPUC pursuant to Section 252(f) of the Telecommunications Act of 1996. Since then, Qwest and competitive local exchange carriers throughout Qwest's region have participated in a collaborative process (also known as the Seven-State Process involving the regulatory commissions of the states of Idaho, Iowa, Montana, New Mexico, North Dakota, Utah and Wyoming, and facilitated by John Antonuk from the Liberty Consulting Group) to explore and resolve literally hundreds of issues relating to specific provisions of Qwest's proposed SGAT in connection with Qwest's intent to enter in-region InterLATA long distance markets in states throughout its region under Section 271 of the Act. With the exception of those recommendations that Qwest has challenged in individual state commissions, the SGAT filed in this docket was generally intended to be consistent with the Seven-State process facilitator's recommendations. The filing also incorporated language agreed to in other states (Washington, Oregon, Colorado, and Arizona). TC00-191

The SDPUC is also part of the Regional Oversight Committee (ROC) 3rd Party Test of Qwest's Operational Support Systems (OSS). Thirteen of the Qwest region regulatory commissions joined the project. Arizona did not join, as it was doing its own test of the OSS, in March 1999. The final report on the OSS testing was expected in March 2002.

HB 1050 An Act to revise the definition of a grain dealer.

HB 1051 An Act to revise the definition of a state agency regarding certain disclosures by a state agency of information concerning a private entity.

CONSUMER AFFAIRS

During calendar year 2001, the Commission received 2,965 consumer complaint contacts which included:

Telecommunication complaints = 2006

Natural Gas complaints = 545

Electricity complaints = 374

The Commission resolved 2849 complaints during calendar year 2001.

During calendar year 2001, the Commission saw an increase in complaints from calendar year 2000. There were 2251 complaints during calendar year 2000. The Commission recovered \$162,621.07 for consumers in 2001.

Regulated Utility Companies

The Commission has territory, complaint and quality of service authority over all natural gas, electric and telecommunication utilities operating within South Dakota. Certain utilities are exempt from the Commission's rate regulation. They include municipal, rural electric cooperatives and small, independent and cooperative telephone companies. The Commission retains its switched access rate making authority for all telecommunications companies providing local service, including small, independent and cooperative companies.

On July 1, 1999, the rates for Qwest Corporation's residential and local exchange service were capped by the South Dakota Legislature at the rates previously set by the Commission and then in effect.

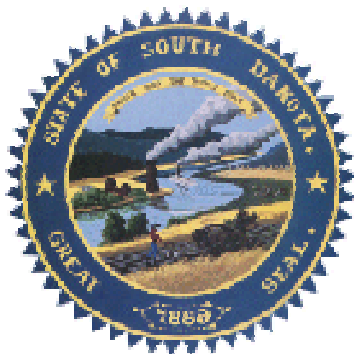
