A Little History...

The arrival of the railroad in Dakota Territory caused great excitement. It would bring the much needed and appreciated transportation services to the remote plains. Along with the excitement quickly came disappointment: there was only one railroad – a monopoly – so it could charge whatever the travelers would pay. The settlers felt they were being cheated, so they took their complaints to the territorial government.

In 1882, the territorial legislature created an ad hoc committee to deal with railroad issues. Each year the committee became more burdened with the impact railroads had on Dakota Territory. Committee members felt there was no authority to enforce their decisions. In 1885, the territorial legislature established the Board of Railroad Commissioners. Its powers and duties were implemented in 1886.

The first session of the South Dakota Legislature (1889) expanded the commission, increasing its powers and duties. The board consisted of three members serving a two-year term, or at the pleasure of the governor.

Since most grain facilities were adjacent to the railroads, regulation of grain warehouses was added to the board's jurisdiction in 1890. In 1897, commissioner offices became elected positions, accountable to the voting public. Each term of office was defined as a six-year term, with one commission position elected each two years during the general election. Amendments in 1897 also gave the commissioners the power to establish and enforce railroad rates.

In 1909, the legislature abolished the Telephone Commission (created in 1907) and placed authority over telephone and telegraph operation with the Board of Railroad Commissioners.

In 1925, South Dakota became one of the first states to regulate for-hire motor carriers to assure public safety and reasonable rates. Freight rates, service territories and annual permits requiring adequate insurance became part of the commission's responsibility. The board was authorized to develop facts for presentation to the Interstate Commerce Commission and various courts. In 1937, the commission was given authority to test and inspect heavy scales weighing 1,000 pounds and more. Later, the scale authority was assigned to Commerce and Consumer Affairs.

In 1939, the name was changed to the Public Utilities Commission to reflect the wider range of responsibility.

In 1975, the state legislature granted the commission regulation over natural gas and electric utilities.

The Commission...

Consists of three members elected at-large. Commissioners each serve staggered, six-year terms. The current Public Utilities Commission is given legislative and statutory authority under Title 49 of the South Dakota Code.

What we do ...

- ⇒ Assist the public in making wise utility choices, promote consumer utility interests through public policy, and resolve disputes between customers and their utilities. We also regulate the rates and service quality of investor-owned electric, natural gas and telephone utilities.
- Regulate territorial jurisdiction over all retail electric companies, including cooperatives, independents and municipals.
- Register interstate for-hire motor carriers.
- □ Operate the South Dakota Do-Not-Call Registry.
- Administer the state's one-call notification center, which locates underground facilities.
- ⇔ Operates the natural gas pipeline safety program.
- □ License and inspect state public storage, state public grain warehouses and grain dealers.
- Provide information and resources to property owners interested in wind energy development.

~ Meet the Commissioners ~



Commissioner Bob Sahr is a national leader in protecting consumers and developing telecommunications infrastructure in rural America.

In 2003, Bob led the effort to pass the South Dakota Do-Not-Call List. As a result, more than 312,300 South Dakota landline and cell phones are on the list with these households receiving far fewer telemarketing calls.

From 2002 to present, Bob has spearheaded a first-of-its-kind-in-the-nation program to build more cell phone towers. This has led to unprecedented investment in new cell tower sites in South Dakota with service coming to many rural communities for the first time. Bob strongly supports policies to ensure South Dakotans continue to have access to state-of-art wire line communications. He was a tireless backer of the successful re-nomination of Commissioner Jonathan Adelstein to the Federal Communications Commission.

Commissioner Sahr is a grass-roots advocate for wind power and renewable energy. Bob's efforts helped make South Dakota's first major wind farm a reality in rural Hyde County near Highmore, and his leadership and innovation have the state PUC recognized as a national leader in wind energy efforts.

Bob was elected chairman of Qwest's Regional Oversight Committee, comprised of regulators in 14 states where Qwest is the dominant local telephone carrier. He was elected Secretary of the Mid-America Regulatory Conference, a 15-state association of public utilities commissioners. He began terms for both offices in 2005. Bob also serves on the Telecommunications Committee of the National Association of Regulatory Utility Commissioners.

In 2004, Bob traveled to China with the American Council of Young Political Leaders. He was one of 10 young leaders in the nation selected for this prestigious international exchange program.

Bob grew up in Pierre where he was a member of the back-to-back state champion high school tennis team. He graduated with honors from the University of Colorado, Boulder in 1989 and worked in sales and marketing for Michelin Tire Corporation. Bob earned his law degree from the University of Colorado School of Law where he was selected to Who's Who Among American Law Students.

Bob and his wife, Christine, welcomed their first child, Allison, in November 2002. He serves on the Pierre Municipal Library Board and is the past chair for the local United Way fundraising drive, past president for Oahe Habitat for Humanity, and past board member for Countryside Hospice Board and the State Bar of South Dakota Bar Commission.



Commissioner Dustin "Dusty" Johnson was sworn in as Public Utilities Commissioner in January 2005, becoming the youngest utility commissioner in the nation.

Since taking office, Dusty has been dedicated to protecting consumers and to helping communities, businesses and families acquire the telecommunications and energy infrastructure they need to succeed. He serves as chairman of the transmission subcommittee of the Governor's Energy Task Force and on the National Association of Regulatory Utility Commissioners' Electricity Committee. In early 2005, he served as co-chair of a national effort to oppose the federal proposal to raise the rates charged for hydropower by the Power Marketing Administrations.

Prior to joining the PUC, Dusty served as the senior policy advisor to Governor Michael Rounds for economic development, corrections, and transportation issues and was a prime architect of the 2010 Initiative, a plan for economic growth for South

Dakota. He has also served as a management analyst for local governments in the Kansas City area and as a Truman Fellow for the U.S. Department of Agriculture in Washington, D.C.

Dusty is originally from Pierre, and received his bachelor's degree in political science from the University of South Dakota and his master's degree in Public Administration from the University of Kansas. In 1998, he was named a Harry S. Truman Scholar.

Dusty, his wife Jacquelyn, and their son Max make their home in Mitchell.



Commissioner Gary Hanson was elected to the South Dakota Public Utilities Commission in November 2002, and served as commission chairman in 2005. He was selected as the South Dakota representative on the Organization of MISO States and is a member of the National Association of Regulatory Utility Commissioners' Energy Resources and the Environment Committee. Gary has also been selected by NARUC to serve on the National Wind Committee.

Gary is the fourth generation of his family to live and work in South Dakota. He is uniquely qualified to assure that issues before the PUC will be thoughtfully considered and thoroughly examined in a fair-minded and non-partisan manner. Gary was twice elected as utilities commissioner of Sioux Falls where he was responsible for the development and day-to-day activities of three municipal utilities.

Gary was also twice elected Mayor. As the city of Sioux Falls chief executive and administrator, Gary oversaw 1,000 full-and part-time employees and a budget of \$204 million. During Gary's service as a locally-elected official, Sioux Falls grew by more than 33,000 people.

Prior to local service, Gary served three terms as a state senator, where he was chairman of the Government Audit and Operations Committee, and vice chairman of the Senate Taxation Committee. He is a founder and past chairman of the Lewis and Clark Rural Water System and active in South Dakota Water Development. Gary is a real estate broker and served as president of the Sioux Falls Board of Realtors.

Gary is active on several community and industry boards. He regularly shares his passion for athletics as a volunteer coach in a variety of youth sports, and enjoys hunting, fishing, and skydiving. Gary is also a licensed soccer coach, and a lifetime member of the Lions Sight and Service Foundation.

Gary was honored as Outstanding Young Citizen of South Dakota, Sioux Falls City Father of the Year, and was inducted into the YMCA Tri-State Hall of Fame. He is a recipient of Habitat for Humanity's Hat's Off award, Spirit of Downtown Sioux Falls award, White Cane Safety award, Childrens Care Hospitals' WINGS of Love award, was named as Distinguished Alumnus of Northern State University, and Multiple Sclerosis Society Chapter Mayor of the Year.

- **Dustin Johnson** was sworn in as South Dakota's newest Public Utilities Commissioner Jan. 4, 2005.
- The PUC hosted a Conference on the State of America's Energy in Sioux Falls during April. More than 200 attended, including keynote speaker Federal Energy Regulatory Commission Chairman Pat Wood III. U.S. Senators Tim Johnson and John Thune addressed the attendees from Washington, D.C. via live broadcasts.
- PUC officials and Federal Communications Commissioner Jonathan Adelstein took a Broadband Road Trip across South Dakota in August, highlighting the importance of high speed internet to rural America's economy. The communities visited were Sioux Falls, Mitchell, Groton, Kennebec, Pierre, the Cheyenne River Indian Reservation, Philip and Deadwood.
- The PUC and the **U.S. Department of Energy** hosted a **Regional Wind Conference** in Brookings during September with more than 260 attendees. Keynote addresses were given by DOE's Wind Powering America National Coordinator Phil Dougherty of Washington, D.C. and Xcel Energy's CEO Dick Kelly of Minneapolis, Minn.
- The PUC's Wireless Initiative continued with new or expanded service coming to many communities, including Bowdle, Goodwill, Lake Andes, Miller/St. Lawrence, Plankinton, Tabor, Tyndall, Wall and Whitewood. The PUC worked closely with community leaders to invite and encourage cellular providers to erect towers in these areas.
- The PUC successfully **led a nationwide effort to block a federal proposal aimed at substantially increasing electricity rates for public power customers**. If passed, the proposal would have increased rates to South Dakota consumers by an estimated \$147 million from 2007 to 2011 and \$55 million per year after 2011.
- The PUC was instrumental in **breaking a federal logjam on cell phone tower** applications that was delaying many South Dakota sites. PUC Commissioners spearheaded a national resolution on the issue and successfully lobbied the Federal Communications Commission to allow the towers to be built.
- The PUC secured **refunds totaling \$3.4 million** for Montana Dakota Utility customers in the state, given a rate increase protest filed with the Federal Energy Regulatory Commission five years ago.
- **Bob Sahr** was elected secretary for the **Mid-America Regulatory Conference**, which is a 15-state association of public utilities commissioners, and will serve as the group's president in 2009.
- Gary Hanson was appointed by the National Association of Regulatory Commissioners President, Diane Munns, to represent NARUC on the National Wind Coordination Committee.
- Bob Sahr was elected Chairman of the Qwest Regional Oversight Committee, a 14-state group comprised of telecommunications regulators in states where Qwest is the dominant local telephone carrier.

HIGHLIGHTS continued

- The PUC commissioners attended **public meetings on cellular phone service** in Tulare, Hitchcock, Onida, Canistota and Mina Lake. The commissioners attended **public meetings on cellular service and wind energy** in Frankfort, Veblen, Britton and Sisseton. Also, the commissioners attended **public meetings on wind energy** in Freeman, Wessington Springs, Highmore, Mission and Redfield.
- The PUC assisted in **hosting public meetings** on **energy efficiency** and reducing energy costs during the South Dakota State Fair in Huron, as well as in Mobridge, Pierre, Rapid City and Spearfish.
- Land lines and wireless phones registered by South Dakotans on the national **Do-Not-Call List** increased to 269,863 in September, the two year anniversary of the registry.
- The commission logged **1,883 consumer contacts** in 2005, in addition to informally answering thousands of consumer questions at public events. The PUC received petitions, e-mails, phone calls and letters from thousands of South Dakotans requesting improved cell phone service.
- The PUC began **Web casting commission meetings and hearings** to make it easier for the public and utility industry representatives to access these meetings.
- The commission worked for successful passage of **new legislation** (SB 17) to assist in the development of wind farms in South Dakota.
- The commission worked for successful passage of a **new South Dakota law (SB 20) which prohibits a telecommunications provider from including consumers' cellular phone numbers** in a directory without consumer authorization.
- The commissioners drafted and secured the passage of a National Association of Regulatory Utility Commissioners' **resolution to slow the phase-out of analog cell phone service**. Many rural South Dakotans rely on the stronger and farther reaching analog signals for cellular use in their area versus digital signals.
- The PUC held **public hearings on utility projects** in Groton for Basin Electric's proposed project in that area; in Huron for the Dakota Turkey Grower's requested electric service provider; and in Brandon and White for Xcel Energy's proposed new transmission lines and substations.
- The commissioners serve as **committee chairs for the Governor's Energy Task Force** and played a key role in the drafting of the Energy Report.
- The commissioners and staff served as **liaisons between state government and electricity and telecommunications providers during the blizzard** and widespread power outages in 2005.
- We are very proud to have a member of our staff, **Justin Blais**, **serving in Iraq** with Yankton C "Charlie" Battery.

REGULATED UTILITY COMPANIES

The Commission has territory, complaint and quality of service authority over all natural gas, electric and telecommunication utilities operating within South Dakota. Certain utilities are exempt from the commission's rate regulation. They include municipal, rural electric cooperatives and small, independent and cooperative telephone companies. The commission retains its switched access rate making authority for all telecommunications companies providing local service, including small, independent and cooperative companies.
