Dear Ms. Van Gerpen:

Pursuant to the Settlement Stipulation in Docket No. EL14-072, MidAmerican Energy Company ("MidAmerican") is required to perform quarterly reviews of its Clause ECA – Energy Cost Adjustment. Per the Stipulation, when the projected cumulative account balance divided by projected jurisdictional sales equals or exceeds \pm \$0.001, a revised ECA factor will be determined and filed for implementation with the next month's billing cycle.

MidAmerican submits the quarterly review for the period ending July 31, 2024. The revised factor of \$0.00258 will become effective with billings on August 28, 2024. There is a correction to the trial balance for the months of May and June on the OverUnder Estimate tab of the 2nd Quarter 2024 SD ECA Review – Confidential workbook. MidAmerican also submits the following revised electric tariff sheet:

Pursuant to S.D. Admin. R. 20:10:01:39 et seq., MidAmerican respectfully requests confidential treatment of the file 2^{nd} Quarter 2024 SD ECA Review - Confidential. MidAmerican respectfully requests that 2^{nd} Quarter 2024 SD ECA Review - Confidential should be accorded confidential treatment for three years or such time as the Commission may deem reasonable.

The confidential materials constitute a trade secret and, if released, would give an advantage to competitors and serve no public purpose. If MidAmerican's competitors or customers were to gain access to these negotiated energy charges or coal prices, MidAmerican's ability to minimize electric costs that are billed to customers would be impaired. The confidential material contains commercially sensitive information, which if released to the general public, would give an unfair advantage to existing and potential electric suppliers and customers. *Food Marketing Institute v. Argus Leader Media*, 139 S. Ct. 2356, 2358 (2019).
