Dear Ms. Van Gerpen:

MidAmerican Energy Company ("MidAmerican") hereby submits the Energy Cost Adjustment ("ECA") reconciliation for 2024 in accordance with the provisions on MidAmerican's tariff sheet Section Number 3, Sheet Number 76 and the fourth quarterly calculation of the ECA factor, in accordance with the Settlement Stipulation in Docket No. EL14-072. The new ECA factor is effective with the first March 2025 bill groups through the final February 2026 bill groups. Consistent with the Settlement Stipulation, MidAmerican will review the ECA balances quarterly and when the projected cumulative account balances equals or exceeds \pm \$0.001, MidAmerican will determine the revised ECA Factor and file a new ECA factor for implementation with the next month's billing cycle.

Included in this filing are the following four (4) items:

- (1) 2025 Confidential Exhibit 1 Calculation of 2025 ECA Factor;
- (2) 2025 Exhibit 2 -Calculation of Factor A (Over)/Under Balance;
