Dear Ms. Van Gerpen:

Pursuant to Section No. 3, Sheet No. 33.1 (5) of NorthWestern Energy's Electric Tariff, enclosed is 324th Revised Sheet No. 33a and 107th Revised Sheet No. 33b.

Sheet Nos. 33a and 33b reflect changes in the delivered cost of fuel, delivered cost of energy and ad valorem taxes paid to be effective August 1, 2024.

The effect of Sheet Nos. 33a and 33b for a typical Rate 10 residential service customer using 750 Kwh per month would be an increase in the monthly cost of \$1.27. The new monthly cost effective August 1, 2024 is \$113.23. The monthly cost effective May 1, 2024 was \$111.96.
