Enclosed is the detail for determination of the Energy Adjustment Rider rates by Service Category based on the three months ending March 2026. The new adjustment factor is applicable for usage on or after May 1, 2026.

Per Commission approval in Docket No. EL22-025 Otter Tail Power Company calculates rates as outlined in section 13.01 of the South Dakota Energy Adjustment.

Per Commission approval in Docket No. EL25-022 Otter Tail Power Company uses the actual retail sales to calculate the system delivered costs to calculate the customer EAR rate.

Per Commission approval in Case No. EL25-022, Otter Tail Power includes fuel costs related to steam and water sales to POET Biorefining (POET) in the EAR.
