RE: ANNUAL SMALL GENERATOR FACILITY INTERCONNECTION REPORT

Dear Ms. Van Gerpen:

Northern States Power Company, doing business as Xcel Energy, submits this Small Generator Facility Interconnection Report in accordance with ARSD § 20:10:36:63 which requires:

“.....The public utility shall annually provide to the commission a list of each small generator facility that is interconnected to the public utility's EDS during the calendar year and shall include the size of the facility, the amount paid by the small generator to the public utility for interconnection, the date of the application, and the date the interconnection was completed. The report for the calendar year is due the following March 1.”

Please see Attachment A for interconnections for the year 2019.

In addition, we provide a final update to our November 15, 2018 submission where we submitted interconnection information for projects that occurred between 2010 and 2017. We identified six projects that were charged higher interconnection fees than established in Docket No. RM08-002 and on March 8, 2019 issued four refund checks including seven percent simple interest per annum<sup>1</sup> from the date of the original payment. We identified the developer for the final two installations and issued refund checks on June 6, 2019.

During the aforementioned refund process, we discovered a seventh installation which submitted an application in 2017 but did not interconnect until 2019. We issued a refund for that installation on March 8, 2019.
