Sprint Communications Company, LP ("Sprint") respectfully requests leave to file a supplemental memorandum in opposition to Native American Telecom, LLC's ("NAT") Application for Stay of Administrative Proceedings Pending Judicial Review ("Application"). On June 30, 2011, after Sprint had served and filed its Memorandum in Opposition to NAT's Application, NAT filed a document entitled "Memorandum in Support of Application for Stay of Administrative Proceedings Pending Judicial Review," in which NAT responds to arguments raised by Sprint, and presents new argument and facts in support of its Application.
