## **Consumer Reports**

 Status Report on Consumer Utility Inquiries and Complaints Received by the Commission (Consumer Affairs: Deb Gregg)

The Commission received a total of 57 contacts since the last report was prepared for the May 26, 2015 Commission meeting.

8 contacts involved telecommunication services, 25 contacts involved electrical services, 1 contact involved natural gas service, 3 contacts were related to wireless service, 8 contacts were related to the Do Not Call Registry, 1 contact was related to the Dakota Access Pipeline, 1 contact was related to the Keystone XL Pipeline and 10 contacts were related to issues not regulated by the PUC.

1,914 of the 1,916 complaints received in 2014 have been resolved.

893 of the 910 complaints received in 2015 have been resolved.

### **Electric**

1. EL15-018 In the Matter of the Joint Request for Service Rights Exception between NorthWestern Corporation dba NorthWestern Energy and Central Electric Cooperative, Inc. (Staff Analyst: Eric Paulson; Staff Attorney: Kristen Edwards)

Mr. Brian Bultje, Central Electric Cooperative, Inc. (Central Electric), asked that the Commission

grant approval for Central Electric to provide single phase electrical service to a 10 HP motor for a drain tile pump system located within NorthWestern's territory. Mr. Eric Paulson, staff analyst, recommended that the Commission grant approval of the service rights exception.

Commissioner Hanson moved to approve the requested service rights exception between NorthWestern and Central Electric. Motion carried 3-0.

2. EL15-020 In the Matter of the Application by Wind Quarry Operations, LLC, for a Wind Energy Facility Permit for the Willow Creek Wind Energy Facility and Associated Facilities (Staff Analysts: Brian Rounds, Darren Kearney; Staff Attorney: Kristen Edwards)

Ms. Kristen Edwards, staff attorney, recommended that the Commission assess a filing fee not to exceed \$305,000 with an initial deposit of \$8,000, and authorize the Executive Director to enter into necessary consulting contracts. Mr. John O'Meara, Wind Quarry Operations, LLC (Wind Quarry), stated Wind Quarry had no objection to the filing fee.

Commissioner Fiegen moved to assess a filing fee not to exceed \$305,000 with an initial deposit of \$8,000 and authorize the Executive Director to enter into necessary consulting contracts. Motion carried 3-0.

Commissioner Nelson moved to grant Keystone's Motion to Preclude Consideration of Aboriginal Title or Usufructuary Rights. Motion carried 3-0.

Commissioner Nelson moved to grant Keystone's Motion to Preclude Testimony Regarding Mni Wiconi Pipeline Easements. Motion carried 3-0
