

Crowned Ridge Wind, LLC ("Crowned Ridge") has reviewed the procedural schedule proposed in the Motion for Procedural Schedule submitted by Staff of the South Dakota Public Utilities Commission ("Staff") on March 26, 2019. Crowned Ridge agrees with the dates in the proposed schedule, with one clarification regarding discovery, that we believe is acceptable to Staff, which is that Crowned Ridge requests that the deadline for Applicant's Supplemental Testimony be April 10, 2019 rather than April 8, 2019.

In addition, Crowned Ridge requests an additional hearing time be scheduled on June 18 or 19 for one witness who is unavailable for the proposed evidentiary hearing on June 11-14.


