Consumer Reports

1. Status Report on Consumer Utility Inquiries (Consumer Affairs: Deb Gregg)

The Commission received a total of 61 contacts since the last report was prepared for the July 9, 2019 Commission meeting.

6 contacts were related to telecommunication services, 24 contacts were related to electrical services, 1 contact was related to natural gas service, 1 contacts was related to gas and electric service, 3 contacts were related to wireless service, 8 contacts were related to the Do Not Call Registry, 1 contact was related to One Call and 17 contacts were related to issues not regulated by the PUC.

Contacts received in 2019: 715 of the 730 have been resolved.

Commissioner Nelson moved to approve Applicant's proposal of Brian Riniker as a public liaison officer. Motion carried 3-0.

EL19-012 In the Matter of the Application by Sweetland Wind Farm, LLC for Facility Permits for a Wind Energy Facility and a 230-kV Transmission Facility in Hand County, South Dakota for the Sweetland Wind Farm Project (Staff Analysts: Darren Kearney, Jon Thurber, Eric Paulson; Staff Attorneys: Kristen Edwards, Mikal Hanson)

Commissioner Fiegen moved to grant the Joint Motion for Approval of Settlement Stipulation and approve the terms and conditions stipulated therein and issue the requested Permits. Motion carried 3-0.

3. EL19-022 In the Matter of Black Hills Power, Inc. dba Black Hills Energy's Application for Adjustment to Its Cogeneration and Small Power Production Service Simultaneous Net Billing Generation Credit Rate(s) (Staff Analyst: Brittany Mehlhaff; Staff Attorney: Kristen Edwards)

Mr. Jason Keil, Black Hills Power, Inc. dba Black Hills Energy (BHE), asked that the Commission approve the revised tariff sheets and updated generation credit rate effective August 1, 2019. Ms. Brittany Mehlhaff, staff analyst, recommended that the Commission approve BHE's request.

Commissioner Hanson moved to approve the revised tariff sheets and updated generation credit rate, as filed on July 11, 2019, effective August 1, 2019. Motion carried 3-0.

4. EL19-024 In the Matter of the Joint Request for an Electric Service Boundary Change between Northern States Power Company dba Xcel Energy and Sioux Valley-Southwestern Electric Cooperative, Inc. dba Sioux Valley Energy (Staff Analyst: Lorena Reichert; Staff Attorney: Kristen Edwards)

Mr. Steve Kolbeck, Northern States Power Company dba Xcel Energy and Michele Nielson, Sioux Valley-Southwestern Electric Cooperative, asked that the Commission approve the service territory boundary change. Ms. Lorena Reichert, staff analyst, recommended that the Commission approve the request.

Commissioner Nelson moved to approve the service territory boundary change. Motion carried 3-0.

5. EL19-026 In the Matter of the Application by Tatanka Ridge Wind, LLC for a Permit of a Wind Energy Facility in Deuel County, South Dakota (Staff Analysts: Darren Kearney, Jon Thurber, Joseph Rezac; Staff Attorneys: Kristen Edwards, Amanda Reiss, Mikal Hanson)

Mr. Brett Koenecke, May, Adam, Gerdes & Thompson LLP, representing Tatanka Ridge Wind, LLC (Tatanka), stated Tatanka didn't object to the procedural schedule and filing fee. Ms. Kristen Edwards, staff attorney, recommended that the Commission approve the procedural schedule, authorize the executive director to enter into necessary consulting contracts and assessing the filing fee per statute.

Commissioner Fiegen moved to assess a filing fee not to exceed \$308,000 with an initial deposit of \$8,000, authorize the executive director to enter into necessary consulting contracts, and adopt the procedural schedule filed in the docket. Motion carried 3-0.

6. EL19-027 In the Matter of the Application by Crowned Ridge Wind II, LLC for a Permit of a Wind Energy Facility in Deuel, Grant and Codington Counties (Staff Analysts: Darren Kearney, Jon Thurber, Eric Paulson; Staff Attorney: Kristen Edwards, Amanda Reiss, Mikal Hanson)

Mr. Miles Schumacher, Crowned Ridge Wind II, LLC (Crowned Ridge), stated Crowned Ridge did not object to the filing fee and granting intervention to all the individuals that filed. Ms. Kristen Edwards, staff attorney, recommended that the Commission assess a filing fee not to exceed \$412,500 with an initial deposit of \$8,000 and authorize the executive director to enter into necessary consulting contracts. Staff also didn't object to the interventions.

Commissioner Hanson moved to assess a filing fee not to exceed \$412,500 with an initial deposit of \$8,000, authorize the executive director to enter into necessary consulting contracts and, grant party status to Amber Christenson, Allen Robish, and Kristi Mogen. Motion carried 3-0.
