Consumer Reports

1. Status Report on Consumer Utility Inquiries (Consumer Affairs: Deb Gregg)

The Commission received a total of 60 contacts since the last report was prepared for the August 6, 2019, Commission meeting.

Eighteen contacts were related to telecommunication services, nine contacts were related to electrical services, one contact was related to gas and electric service, nine contacts were related to wireless service, seven contacts were related to the Do Not Call Registry, two contacts were related to the TransCanada Keystone Pipeline, two contacts were related to Wind Energy, seven contacts were related to the Grain Warehouse Division and 5 contacts were related to issues not regulated by the PUC.

Contacts received in 2019: 812 of the 834 have been resolved.
