STIPULATION FOR FIRST PAYMENT TO PRODUCERS

The Parties hereby stipulate and agree that Receiver or Farmers Cooperative Elevation

*

(FCE) may make payments to producers owed for the sale of grain as detailed below. The

Parties state and agree as follows:

- 1. Pursuant to the Court's Order Appointing Receiver, payments outside of those made in the ordinary course of business may not be made without prior court approval.
- 2. As detailed in the most recent monthly report, general payables have reduced from \$929,979 to \$304,546.
- 3. The Parties agree that it is now achievable and appropriate to begin paying grain payables, which currently stand at \$1,467,627.
- 4. Subsequent to the filing of the November monthly report to the court, cash in the Receiver Account increased to approximately \$86,000. This is due to receipt of lease payment and payment for grain inventory.
- 5. Dividend payments from AGP in the amount of \$71,396.72 from 2021 and \$192.271.17 from 2014 and part of 2015 were received in December.
- 6. The Parties stipulate to and request to pay \$124,577.72 for annual term note for grain payables that was due in September. They will still be owed \$554,597.86
- 7. The Parties stipulate to and request to pay \$222,791.45 to producers at this time, with that amount distributed as follows:

\$222,791.45 to producers owed for sale of grain and \$124,577.72 for annual term payment.
