## FINAL NOTICE DEMANDING PAYMENT OF CIVIL FINE

On July 3, 2024, the South Dakota Public Utilities Commission (PUC) issued a Final Order and Notice of Entry in the Matter of PUC Staff's Complaint Against Yield10 Bioscience, Inc. of Woburn, MA, Docket GW24-001, assessing civil fines against Yield10 in the total amount of fifteen thousand dollars (\$15,000). The PUC Order was served upon you on July 3, 2024. Pursuant to the Order, payment of the full amount was due August 3, 2024.

Emails were also sent to Charles Haaser on August 20, 2024, and September 30, 2024, requesting payment. As of December 12, 2024, payment of fifteen thousand (\$15,000) has not been received.

Be advised this is a 14-day final notification to debtor and demand for payment pursuant to SDCL 1-55-7. If payment is not received, the PUC may seek judgment in Circuit Court against you or refer this debt to the state obligation recovery center center for collection of the civil fine of fifteen thousand dollars (\$15,000) ordered against you on July 3, 2024.

The principal and total amount of this debt is fifteen thousand dollars (\$15,000). The debt will not be turned over for collection or judgment until a time at least fourteen days after receipt of this final notice to debtor and demand for payment. If the debt is turned over to the state obligation recovery center, a cost recovery fee of twenty percent (20%) of the fifteen thousand dollars (\$15,000), in the amount of three thousand dollars (\$3,000), will be added to the total debt owned by Yield10 Bioscience, Inc to the PUC.
