## **ABSTRACT**

This report describes the results of the Phase I cultural resources survey of 14.97 miles (24.1 km) and 87,500 ft<sup>2</sup> (8,129 m<sup>2</sup>) of the Nebraska segment of the Rockies Express Pipeline project (REX). Largely, this investigation covered previously inaccessible land parcels, as well as minor Line Change (LC) orders and Extra Work Space (EWS) areas; portions of seven parcels totaling 1.08 miles (1.7 km) remain unsurveyed primarily due to denied access by property owners. Ten Nebraska counties were surveyed during the present investigation, including Perkins, Lincoln, Dawson, Gosper, Phelps, Kearney, Webster, Nuckolls, Thayer, and Jefferson. This report is supplemental to A Phase I Cultural Resources Survey of the Nebraska Segment of the Proposed Rockies Express Pipeline Project (REX) Corridor, Perkins, Lincoln, Dawson, Gosper, Phelps, Kearney, Franklin, Webster, Nuckolls, Thayer, Jefferson, and Gage Counties, Nebraska (Schwegman et al. 2006).

One historic site 25PP22 was identified during the present investigation. This site appears to meet the National Register of Historic Places (NRHP) criteria of significance (36CFR60.6, Federal Register 1976), and if site avoidance proves unfeasible, Phase II testing is recommended in order to make a definitive determination of NRHP eligibility. No other cultural resources were identified and, consequently, no further work is advised. It is recommended that REX project implementation be cleared to proceed in those areas outside of historic site 25PP22 located in Parcel No. NE-PH-030 in Phelps County, Nebraska, pending completion of archaeological investigations for the remaining access-denied properties.
