Rob,

Thank you for the information you submitted concerning TransCanada Keystone's emergency response capabilities. Unfortunately, it was not the information we were looking for nor did it address what we had requested from John Hayes during our meeting in November. During our meeting, John presented us with lots of good information about TransCanada Keystone's response capabilities in South Dakota. Based on that, we requested a brief, written description of what would happen during a release event in South Dakota. Basically, we are looking for a narrative describing the sequence of response activities that would occur during a release in South Dakota. Information to be incorporated into the narrative should include, but is not limited to: the notification sequence, contact information the DENR should use to stay in communication during the event, description and role of local TransCanada resources (including local contractors (environmental and yellow steel)), and estimated response times for both local and out-of-state resources.

Please provide the requested information as soon as possible so the department can move forward with it's review of the Keystone Emergency Response plan. If you have any questions, please feel free to contact me.
