As a concerned landowner, I am opposed to the Dakota Access Pipeline. The proposed pipeline will run diagonally across my land west of Tea, by Highway 17 (Legal description: Delapre township Section Township Lot 789, Legal SE 1/4 EX RD and Andreessen farm 32-100-51 and Lot 786 Legal SW 1/4-32-100-51.) That pipeline would be detrimental to my property's value and my future income. It would have a serious impact on the environment, also. Tea is growing west, very close to my farm. However, nobody would want to build on land with the pipeline running under it, so it would affect the housing development of that region. There is a possibility of an oil leak or explosion from that pipeline, which would ruin that land forever, and very likely get into the water, harming people, plants, and animals. I am also concerned about the company's plan to only pay for crop loss the first three years, and not an annual lease.

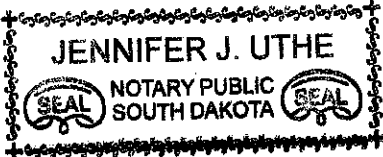
