(a) On April 1, 2015 Objectors served discovery on Dakota Access, LLC;

(b) On May 2, 2015 incomplete and unsigned discovery responses were received

from Dakota Access, LLC. The responses are collectively attached as Exhibit

A;

(c) On May 2, 2015 attorney Koenecke state that "we plan to send complete responses early next week";

- (d) On May 7, 2015 an email was sent to attorney Koenecke due to the fact that no further responses had been received. Attorney Koenecke on May 7, 2015 state that “we’ll get final answers out tomorrow afternoon.” No responses were received on May 8, 2015;

The current Procedural Schedule simply is no longer workable due to Dakota Access, LLC’s discovery delays.
