I see by media accounts of the PUC meeting held on Monday, November 30th that the topic of organic farming was discussed. It is not a matter of state law but common courtesy to resolve and keep in place the organic designation on the land that operate as organic. Federal rules dictate how operations are certified in this country. I would assume that as a common carrier that Dakota Access will obey and follow all federal rules and requirements in it's process to build and construct across the state of South Dakota. Again, I would like to remind that my letter of April 30th which has never been answered to this point was in the hands of Dakota Access long before the land owner signed the easement. As commissioner Gary Hanson has pointed DAP has not proven it's ability to work with land owners and operators. Commissioner Nelson in his public statement stressed the need for DAP to be cooperative in their approach to SD residents and land owners. As 25 year tenant on this property , I feel I am within my rights to have my financial concerns addressed. That is only the good SD way.
