Dear Commissioners:

Previously, you asked me about re-routes referenced in my April 8 letter in which were not identified as alternate routes prior to that time. I write to share more information about those.

The first is in Lake County and is approximately two miles in length. It was identified in response to landowner preferences and represents the wishes of affected landowners as we understood them to be. The exact reason for the change was to move the pipeline further away from several homes.

The second is in McPherson County, about one mile in length, and, again, is in response to landowner preferences which we have identified. This was due to the request of one landowner impacted.

The third is in Edmunds County, a bit longer, and was created to meet the needs of the solitary landowner involved. The route change was made to accommodate the request of one landowner; the change resulted in the pipeline route getting off one other landowner and on to (3) new landowners (who were all sent notices of the PUC meetings).

The landowners from whom we seek easements for these changes are on the notice list we filed. There are some properties in Edmunds County toward whom the route has moved who were not sent notice as it was not required at the time notice was given. All of these persons received constructive notice through the publication done by the PUC pursuant to law.
