- For time period of January 1, 2020 to present time – any and all communications of any kind whether hard copy or electronic sent be or received by you with any person, or entity, or employee or agent of or representative of Summit Carbon Solutions LLC or SCS Carbon Transport LLC or any other Summit related person or entity.
- For time period of January 1, 2020 to present time – any document of any kind whether hard copy or electronic you have authored or participated in creating that was provided to any lobbyist or elected official related to Glacial Lakes and any Carbon Capture project or Carbon Dioxide pipeline.
- Annual and Quarterly Financial Statements and Balance Sheets for each Glacial Lakes ethanol plant for the years 2020, 2021, 2022, and 2023.

- Minutes from any and all Board of Directors meetings that you were present at or participated in for an Glacial Lakes entity for the years 2020, 2021, 2022, and 2023.

YOU SHOULD TREAT THIS DOCUMENT AS YOU WOULD A COURT ORDER. IF YOU FAIL TO COMPLY WITH THE COMMAND(S) IN THIS DOCUMENT WITHOUT ADEQUATE EXCUSE, THE COURT MAY FIND YOU IN CONTEMPT AND ASSESS MONETARY OR OTHER SANCTIONS AGAINST YOU.
