Ms. Ellett,

This is in response to your message regarding the proposed SCS Carbon Transport LLC pipeline. I understand your concerns as a landowner near the proposed project's route.

The Public Utilities Commission received a siting permit application for this pipeline project on Feb. 7, 2022, resulting in the opening of docket <u>HP22-001</u>. This docket will receive a detailed review of the proposed project by the commission, with a final decision required by law by Feb. 6, 2023. Public input meetings will be held along the pipeline's route. You will find a list of these meetings, scheduled for March 22-25, in the docket.

You may find information addressing some of your concerns during the explanation provided by the project's permit applicant during the public input meetings. I encourage you to attend one of these meetings. In addition, a large amount of further project information will be requested, filed in the online docket, and be publicly available during the year ahead.

If you are unable to attend a public input meeting, you may submit written comments for commissioners and others to review and to be posted in the open docket. In addition to obtaining feedback at these meetings and via written comments, commission staff are in the process of reviewing the project's application to ensure it meets the requirements of South Dakota laws and rules. The project applicant, individuals who were granted party status, and commission staff will present their cases with evidence to the commission. The commission will issue a decision on whether or not to issue a permit based on the record before it and following the criteria provided by state law. This discussion and decision will take place during a public meeting. The processing of a pipeline siting docket can take up to one year.

You suggest delaying a decision on the project. The commission has just begun its work gathering information and investigating this docket, and there is no evidentiary hearing scheduled yet. The commission is required by law to make a decision on the project within one year of the permit application being filed, so there is a great deal of work ahead of us before a decision on issuing a permit is made.

<u>The commission is not involved with eminent domain.</u> Here is an excerpt from the Public Utilities Commission's Information Guide to Siting Pipelines posted online:

The PUC is not involved in the easement acquisition process that occurs between applicants and landowners. Likewise, the PUC does not have a role in the eminent domain process, which is handled in the circuit court system. Landowners with concerns about these issues should seek advice from their personal attorney.

You will find information posted on the PUC's website to guide you in understanding the processing of siting dockets, as well as communicating with the commission on dockets: <u>Information Guide to Siting Pipelines</u>, <u>Informational Guide</u>, and <u>Ex Parte Communications Guidelines</u>.
