We, as affected landowners and concerned citizens, want to inform you of our opposition to Summit Carbon Solutions proposed CO2 pipeline in our area and ask that you join us in opposing it as well.

Summit intends to use the power of eminent domain to seize our property to build a hazardous material pipeline, carbon dioxide, that will jeopardize our safety and the safety of our livestock if and when a leak occurs. Projects of this nature are not public utilities and should not be allowed to use eminent domain.

Unlike water, natural gas, and fuel pipelines, and electrical power lines, CO2 pipelines serve no public purpose. The only reason for the existence of the project is for the profit motives of their individual investors. The precedent set by the granting of eminent domain for projects like this would allow eminent domain to be used for any number of projects for which it was never intended.
