1	Q.	Please state your name and business address for the record.
2	А.	Todd Brown, 1007 Eagle Run, Dell Rapids, SD 57022
3	Q.	What is your occupation?
4	A.	I am a Minnehaha County farmer.
5	Q.	Please briefly describe your operation.
6	A.	It is our family farm. My father and mother are still on the place. My two sons work as
7	well for the farm along with my wife Michelle and I. We raise corn, soybeans and alfalfa as well	
8	as beef cattle.	
9	Q.	Please describe your affiliation with Dakota Ethanol.
10	A.	I was on the steering committee formed in 1999 that led to Dakota Ethanol. I was a
11	founding member of the parent company, Lake Area Corn Processors, and have been a member	
12	of the board since 2001. I currently serve as the Treasurer of the Board for Dakota Ethanol and	
13	3 Chair of the Board for Lake Area Corn Processors.	
14	Q.	Have you previously submitted direct testimony and exhibits in this proceeding?
15	A.	No I have not. I did appear and speak at the Minnehaha County zoning proceeding.
16	Q.	What is the basis for your surrebuttal testimony?
17	A.	I seek to rebut the anticipated rebuttal testimony of those who suggest that farmers and
18	8 landowners in South Dakota do not rely on the strength of the ethanol industry. I will also rebut	
19	anticipated testimony that Summit Carbon's project is not needed for the ethanol industry and the	
20	farmers who support ethanol. I will also seek to rebut the anticipated rebuttal testimony	
21	regarding farming and raising cattle during and after the placing of a permanent easement on	
22	farm ground. I have farmed property with a natural gas pipeline located on it for decades. I have	
23	tiled across that pipeline many times over the years. This has not been a problem for our farm.

Q. To which anticipated witnesses are you responding in your surrebuttal testimony?

25 A. I believe other landowners and farmers who oppose the project.

26 Q. How do you respond to the concerns stated by others?

A. We signed easements with the Navigator project after several meetings. It took those

discussion to get comfortable with that project and the impact it would have our land. We

- 29 understand the concerns others have with permanent easements running across their property but
- 30 for the strength and viability of the ethanol industry and our own future in farming in the region

31 we felt it best to support that project. I also expect after the building of the Navigator project

- 32 across our property that its long-term impact on our farming operation will be minimal.
