He included the legal description of his affected land located in Sanborn County, NE/4 EXC TRACT A OF MORGAN 1ST ADDN 9-105-59. Mr. De Roon’s property is located approximately 95 feet from the centerline of the proposed pipeline.</p> <p>According to the notes provided in the attachment to <i>02/07/25 - Staff’s Recommendation regarding Party Status Applications for the February 11, 2025, Commission Meeting</i>, Mr. De Roon was recommended for denial as the land was believed to be owned by Randall Morgan. Randall Morgan is the owner of the southern half of the quarter. Mr. De Roon owns the northern half via his LLC, Josmer Enterprises.</p>
