## NOTICE OF MOTIONS HEARING

HP24-001

On November 19, 2024, the Commission received an Application for a Permit to Construct a Carbon Dioxide Transmission Pipeline (Application) from SCS Carbon Transport LLC (Summit or Applicant), a limited liability company owned by Summit Carbon Solutions, LLC. Applicant proposes to construct and operate a carbon dioxide (CO2) transmission pipeline (Project). The Project, which has been named the Midwest Carbon Express pipeline, is approximately 2,500 miles of pipelines for the transportation of CO2 from ethanol plants to underground injection wells in North Dakota. The total proposed length of pipelines through South Dakota is approximately 698 miles and will cross the counties of Beadle, Brookings, Brown, Clark, Codington, Davison, Edmunds, Grant, Hamlin, Hand, Hyde, Kingsbury, Lake, Lincoln, McCook, McPherson, Minnehaha, Miner, Sanborn, Spink, Sully, Turner, and Union. The proposed pump stations are planned to be located in Beadle, Edmunds, Lake, Minnehaha, McPherson, and Spink counties.

On January 01, 2025, Staff filed a proposal for procedural schedule. On January 03, 2025, Staff filed an Amended Proposal for Procedural Schedule. On January 03, 2025, Intervenor LeRoy Braun filed an objection to Staff's procedural schedule, and a motion substitute proposed procedural schedule, and motion for approval to present testimony vial live video means.

The Commission has jurisdiction over this matter pursuant to SDCL Chapters 1-26 and 49-41B. A motions hearing will be held by the Commission beginning at 1:30 p.m. CT, Tuesday, January 28, 2025, during the Commission's regularly scheduled commission meeting in the Matthew Training Center, Foss Building, Pierre, South Dakota. The Commission may consider the proposals for a procedural schedule, as well as the request for remote testimony filed by Mr. Braun.

It is therefore

ORDERED, that a hearing on the above matters will be held at the commission's regularly scheduled meeting on Tuesday, January 28, 2025, at 1:30 p. m. CT in the Mathew Training Center, Foss Building, Pierre, S.D. It is further

ORDERED, that any party who wishes to file responses to the proposals for procedural schedule or remote testimony requests must do so by 5:00 p.m. CT on January 23.
