(5) I have not been denied admission to the courts of any state or to any federal court during the preceding five years;





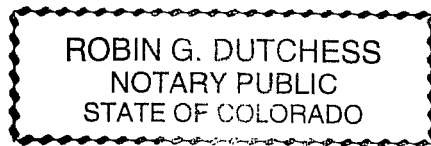
