Fay Jandreau, Assistant General Manager of Venture Communications Cooperative, Inc. in support of Venture's Opposition to New Cingular Wireless PCS, LLC dba AT&T Mobility's (AT&T Mobility) Motion for Partial Summary Judgment, being first duly sworn, deposes and states as follows:

- Although the facilities ordered by AT&T Mobility from Venture are in Venture's end
 office switches, they would not be in the Venture end office switches if AT&T Mobility
 had not ordered them for the purpose of establishing a local presence in Venture's service
 territory.
- The facilities ordered by AT&T Mobility are not used for traffic terminated by Venture.
 They are used for traffic originated by Venture end users and terminated to AT&T Mobility end users.
- 3. The facilities ordered by AT&T Mobility are used to allow Venture end users to dial certain AT&T Mobility numbers as seven-digit local calls. The facilities allow Venture end users to dial AT&T Mobility numbers via seven-digits and to prevent Venture end users from being assessed a toll charge.
- 4. The facilities ordered by AT&T Mobility from Venture are different from the DS1 facilities AT&T Mobility purchases from SDN to transport traffic from Venture to AT&T Mobility. Venture provides a trunk group of 24 DS0 facilities to AT&T Mobility at three (3) Venture end office switches that create a local presence for AT&T in Venture's end offices to allow Venture end users to call certain AT&T Mobility end users using 7-digit dialing. When ordering the 24 DS0's from Venture, AT&T Mobility selected the AT&T Mobility NPA-NXX's Venture end users would be able to dial with

seven-digit dialing. Venture multiplexes these DS0's up to a DS1 level and connects that DS1 to AT&T Mobility. AT&T Mobility uses a SDN DS1 facility for transport to the SDN office in Sioux Falls, which is cross-connected to AT&T's Omaha switch. AT&T Mobility ordered 2-way traffic capability on the subject DS0 trunks, but has not utilized this trunk in the terminating direction.

SDN does not pay Venture for the facilities purchased by AT&T Mobility from Venture.Further your affiant saith naught.
