COMES NOW, Staff of the South Dakota Public Utilities Commission (Staff), Venture Communications Cooperative (“Venture” or “Complainant”) and AT&T Mobility (“Mobility” or “Respondent”) and hereby file this Stipulation and Joint Motion for Adoption of Revised Procedural Schedule.

This docket was opened on May 13, 2020, with the filing of a Complaint of Venture Mobility. The parties to this proceeding are currently Staff, Venture and Mobility, (The Parties). On July 31, 2020 the Parties filed a Stipulation and Motion for Adoption of Procedural schedule. On August 7, 2020, the Commission issued an Order Granting Motion for Adoption of Procedural Schedule; Order Adopting Procedural Schedule; Order Requiring Prefiled Testimony. On March 4, 2021, Staff filed a Letter on behalf of the Parties indicating that the Parties are working to resolve the Complaint informally and requesting the Commission suspend the procedural schedule and postpone the evidentiary hearing scheduled for March 30-31, 2021.

The Parties have engaged in discussions and stipulate to and request the Commission revise the procedural schedule as follows:
