

Facts giving rise to my Complaint are: we intend to construct a new home and shop in an area which is within the territory of Black Hills Power & Light Co. We are presently served by the Black Hills Electric Cooperative, Inc. At the present time, Black Hills Power & Light Co. has no service lines extending to the location where we intend to build. Our property is located in:

Sections 10 and 15 of Township 7 South, Range 3 East of the Black Hills Meridian located in Custer County, South Dakota.

The cost of extending service to our property would be substantially less if our property were transferred from the territory of Black Hills Power & Light Co. to the territory of Black Hills Electric Cooperative, Inc. We have requested that Black Hills Power & Light Co. consent to the transfer and while they have acknowledged that the savings would be substantial, they refuse to consent to the transfer unless the Cooperative is willing to take into consideration the KHW's involved in any future exchanges between the two utilites. At this time we have

exhausted all efforts to resolve this matter with Black Hills

Power & Light Co. The difference in the cost of extending the

service to the site is somewhere between Twenty Thousand Dollars

(\$20,000.00) and Twenty-Five Thousand Dollars (\$25,000.00).

WHEREFORE, we ask that the Commission enter an Order granting the following relief:

That the site of our new home and shop be transferred from the territory of Black Hills Power & Light Co. to the territory of Black Hills Electric Cooperative, Inc.
