### Request for Variance Electrical Master Metering Western Mall Building Sioux Falls, South Dakota

Dear Commissioners:

June 13, 2003

TSP is commissioned to design an upgrade to the existing heating and cooling systems at the Western Mall, in Sioux Falls. Part of that design includes an upgrade to the existing electrical service, to allow for the new heating and cooling loads. The original building was constructed in 1968 and the existing equipment was installed at that time. South Dakota Public Utility Commission rules indicate that, as part of this systems upgrade project, the building must change its electrical meter configuration from a single master meter to individual meters for each tenant. On behalf of the owners, we are requesting a master metering variance to allow continued use of a single master meter.

#### **Existing Conditions:**

The Western Mall is currently served by a central physical plant. The central physical plant includes a large boiler and a central chiller, which serve the heating and cooling needs for all tenants in the building. Tenants with hot water needs have their own water heaters. The existing heating, ventilation and cooling (HVAC) equipment is reaching the end of its useful life and the equipment is becoming hard to maintain.

The existing electrical service is a 2500A, 480/277VAC, 3-phase, 4-wire system, served from a 2500KVA transformer located on the north side of the Mall. This transformer is owned by the Western Mall and the entire service is currently master metered by Xcel Energy on the primary side of the transformer. The owner receives a discounted rate for being a primary metered customer. On average, this rate saves the owner approximately \$19,000/yr, versus being a secondary metered customer. The facility also currently has full generator backup with four existing 750KW generator sets, 3 of which are currently functioning. The Mall currently participates in a program with Xcel Energy where, during peak electrical demand times, Xcel can request that the entire Mall go "offline" and be powered via the generators. The owner also receives a discounted electrical rate from Xcel for participating in this program as well, saving

them approximately \$94,000/year. However, the generator sets, being 30+ years old, have also reached the end of their useful life and have become increasingly difficult to maintain. The owner plans to disconnect and remove those generator sets in the near future.

The larger tenants receive 480/277VAC, 3-phase power directly from main electrical distribution panel. These tenants have transformers which step down the voltage to 208/120VAC for general use. The main distribution panel also serves approximately 6 distribution rooms, located throughout the facility. In these small distribution rooms, the 480/277VAC, 3-phase power is transformed down to 208/120VAC and then distributed to small panels in multiple tenant spaces. Each tenant is served from a separate panel, or group of panels. Larger tenants are served directly from the main distribution panel, while the smaller tenants are served from the smaller distribution rooms, which are served from the main distribution panel. The existing tenant electrical panels do not have the capacity to support additional HVAC roof-top unit loads.

#### Proposed System Changes:

The owner plans to remove the existing boiler, chiller and much of the existing HVAC distribution equipment and replace it with packaged roof-top units for each tenant. Some tenants, depending on the size of the leased space, will have more than one roof top unit for their space. However, no roof-top unit will serve more than one tenant. Each roof-top unit will provide both heating and cooling for each specific tenant space.

The existing electrical panels in each tenant space are not sized large enough to handle the additional load of the proposed HVAC roof-top units for each individual space. The existing main distribution panels are original equipment and do not have the physical space to handle all of the circuit breakers for the proposed HVAC roof top units. Therefore, the owner plans to install a new electrical service entrance and distribution equipment. This new distribution equipment would serve all of the new HVAC equipment and back-feed the existing main distribution panels.

#### PUC Requirements:

Public Utility Commission rules, dated June 13, 1980, and revised on August 7, 1991, Chapter 20:10:26:03, require that "an existing multiple-occupancy building receiving either master metered gas service or electric service, or both, which is substantially remodeled or renovated, beginning after June 13, 1980, for continued use as a multiple-occupancy building"... "shall be individually metered to the units of the building after completion of the remodeling or renovation."

The owner has asked us to request a variance to the above requirements for individual metering 20:10:26:03. The owner wishes to continue using a single master meter on the primary side of the transformer. It is our belief, as well as the beliefs of the owner, the electrical contractor, and Xcel Energy, that converting the building to individual metering is "impractical, uneconomical, and infeasible", per 20:10:26:03. We have enclosed a letter from Xcel Energy expressing their willingness to keep the Western Mall on a primary master meter.

#### Reasons for Variance Request:

Our reasons for this request are based upon the facts that individual tenant metering will be much

more costly, will not result in energy conservation, and will be energy wasteful in the excess materials required to accomplish individual metering.

The existing system is not currently set up for individual metering and the electrical distribution system would have to be drastically changed to accommodate the individual meters. Xcel Energy would have to provide a new utility transformer for the new 480/277VAC service. Xcel Energy must own the transformer if the service is not primary metered. The new service would enter directly into a bank of distribution equipment, which would contain separate meters and circuit breakers for all tenant distribution feeders. A new 480/227VAC feeder would then be distributed to each tenant. The new HVAC roof-top units would be served from the 480/277VAC system. Most tenants currently operate their spaces on a 208/120VAC system, so they would each also need a separate step-down transformer and disconnect switch. Only the 4-5 largest tenants in the Mall currently operate on a 480/277VAC system, with their own step-down transformers for the 208/120VAC system.

A conservative average estimate to make this conversion is approximately \$17,000 per tenant to pull new feeder conductors in conduit, and provide a step-down transformer, disconnect switch, and panel large enough to handle the additional HVAC roof-top unit loads. With approximately 50 tenants in the Western Mall, this adds up to approximately \$850,000 cost to the owner. In addition, since the service could no longer be primary metered, the owner would forfeit the discount rate that he currently gets from Xcel Energy for being primary metered. The owner would also be charged with providing the banks of meter sockets and wiring for all tenant metering. The owner would be forced to pass on the additional costs to the tenants.

It may also prove to be infeasible to create the physical space required to create side-by-side distribution and metering equipment for 50 tenants. There is not currently any space space available for installation of equipment of this size.

The Western Mall tenants would also each pay a higher rate for electricity, due to a much smaller individual tenant consumption total, compared to the entire Mall metered as a single customer. Each tenant would also be assessed a monthly billing charge by Xcel Energy, as individual customers.

The modifications required to change the existing electrical distribution system at the Western Mall into a system that can be individually metered would create a system with a large number of step-down transformers, and result in an energy loss, due to the inefficiencies inherent in transformers. A lower power factor can also be expected, as transformers run at a lower power factor when not fully loaded. In addition, the required electrical system modifications would result in the unnecessary waste of material for additional wiring, conduit, panels, transformers etc...

Currently, the Empire Mall building, also located in Sioux Falls, is also largely master metered instead of individually metered.

On behalf of the owner, we respectfully request that the Commission approve this request for variance. Please feel free to contact me with any questions, or requests for further information.

IN THE MATTER OF THE APPLICATION FOR A MASTER METERING VARIANCE REQUEST FOR THE WESTERN MALL, SIOUX FALLS, SOUTH DAKOTA ORDER GRANTING A MASTER METERING VARIANCE AND CLOSING DOCKET EL03-022

On June 16, 2003, the Public Utilities Commission (Commission) received a letter of application from TSP, on behalf of the owner of the Western Mall, Sioux Falls, South Dakota, applying for a master meter variance in accordance with ARSD 20:10:26:04, et seq. According to the application, the Western Mall is currently served by a central physical plant, which is nearing the end of its useful life and needs to be upgraded. The physical plant is currently served with a single electric meter. The owner is proposing individual roof top units for each of the tenants. Therefore, they are requesting a variance, in accordance with ARSD 20:10:26, to allow the continued use of a single master meter.

On June 19, 2003, the Commission electronically transmitted notice of the filing and the intervention deadline of July 7, 2003, to interested individuals and entities. No petitions to intervene or comments were filed.

Commission Staff (Staff) sent a data request to TSP on June 19, 2003, requesting additional information. Included in the data request was a question regarding how the cost of the electricity was allocated to the tenants. Staff received a response to that data request on August 25, 2003. Staff requested a copy of a sample billing for one month. Upon review of the sample billing it became apparent that Xcel was billing the Western Mall for electrical usage at an interruptible rate which provided lower rates. The Western Mall recalculated the electrical bill for each tenant using Xcel's tariff rates. Based on the information received for the August billing, the Western Mall was billed \$40,268.46 for electric utility service and received \$59,487.34 from its tenants. Staff notified the Western Mall that the manner in which it billed its tenants for electrical service was improper.

On September 19, 2003, Staff met with the consultant, Western Mall management and Xcel officials regarding the variance request. During this meeting Staff again explained the problem with the billing. Also during this meeting Staff became aware that the adjacent Scheels facility, located at 2101 W. 41st St., Sioux Falls, South Dakota, which had recently been constructed, had been master metered without prior Commission approval. Staff requested that the Western Mall send notification to the Commission regarding the design of the facility and why it was master metered.

On November 14, 2003, Staff received the information requested to determine if the changes to the Western Mall met the definition of ARSD 20:10:26:03(3). Upon review of the information Staff determined that requiring individual meters would indeed be uneconomical.

On January 6, 2004, the Commission considered the application of the Western Mall. Staff recommended that the Commission grant the variance request based on the economics of the renovation, see ARSD 20:10:26:03(3). Staff further recommended the following conditions:

a) The Western Mall management shall not charge its tenants for electrical energy above that amount billed by Xcel Energy.

- b) The Western Mall management must submit to Staff, within 14 days of issuance of this order, a detailed description of how the electrical costs will be allocated to each tenant, including the Scheels complex.
- c) The Western Mall management shall submit to Staff a copy of the monthly billings from Xcel to the Western Mall, including the Scheels billing, for the three months following issuance of this order.
- d) The Western Mall management shall submit to Staff a compilation of the monthly billing to the Western Mall tenants to correspond to the billings from Xcel for the three months following issuance of this order.
- e) The Western Mall management shall submit to Staff, within 14 days of issuance of this order, a letter explaining the design of the Scheels facility and how it came to be master metered without prior Commission approval.

The Commission finds that it has jurisdiction over this matter pursuant to SDCL Chapters 1-26 and 49-34A, including 49-34A-4, and ARSD Chapter 20:10:26.

Based upon the application, responses to data requests, and the recommendation of Staff, the Commission finds that the applicant's request for approval of a master meter variance shall be granted with the conditions as recommended by Staff. It is therefore

ORDERED, that the request for a master meter variance is granted to the Western Mall and to the Scheels addition, Sioux Falls, South Dakota, with the following conditions:

- a) The Western Mall management shall not charge its tenants for electrical energy above that amount billed by Xcel Energy.
- b) The Western Mall management must submit to Staff, within 14 days of issuance of this order, a detailed description of how the electrical costs will be allocated to each tenant, including the Scheels complex.
- c) The Western Mall management shall submit to Staff a copy of the monthly billings from Xcel to the Western Mall, including the Scheels billing, for the three months following issuance of this order.
- d) The Western Mall management shall submit to Staff a compilation of the monthly billing to the Western Mall tenants to correspond to the billings from Xcel for the three months following issuance of this order.
- e) The Western Mall management shall submit to Staff, within 14 days of issuance of this order, a letter explaining the design of the Scheels facility and how it came to be master metered without prior Commission approval.

#### It is further

ORDERED, that this docket is closed.
