On behalf of Clean Water Action's 9,063 members in South Dakota, I request that the South Dakota Public Utilities Commission hold additional public comment hearings in several locations throughout the state before a final decision is made on the Big Stone II coal plant and transmission application.

One public hearing, held in September of 2005 in Milbank, was insufficient to adequately address the concerns and questions of residents throughout the state. Additional meetings would be especially helpful since very little information about the proposal's environmental, health, and economic impacts was known at the time of last year's meeting. The draft Environmental Impact Statement prepared for the Western Area Power Administration (WAPA) has brought to light more detailed information about the projected pollution from the proposal. This information should be made part of the public record that the Commissioners use to make the permit decision.

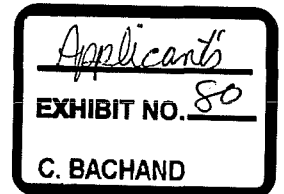
