

In further support of the Application for a Route Permit for High Voltage Transmission Lines in Eastern South Dakota dated January 12, 2006 and filed January 17, 2006, the Applicants submit the following supplemental or amended information:

1. Amendment to Application Section 5.0, Estimated Cost of Facility (ARSD 10:22:09), a true and correct copy of which is attached as Exhibit A.
 - a. The amendment provides the most current estimates for cost of the facility.
 - b. The amendment also replaces and supersedes the submission filed November 28, 2006.
2. Amendment to Application Appendix A.1, Detailed Route Map, a true and correct copy of which is attached as Exhibit B.
 - a. The revised map shows the current proposed route, the reason for any modifications from the original proposed route, and includes the Lake Albert State Waterfowl Refuge boundaries.
 - b. The amendment also replaces and supersedes the submission filed November 10, 2006.
3. Supplement to Application Section 12.1.2 Sensitive Species, a true and correct copy of which is attached as Exhibit C.


- a. The supplemental information addresses the Lake Albert State Waterfowl Refuge.
4. Supplement to Application Section 14.2, Land Use Impacts, a true and correct copy of which is attached as Exhibit D.
 - a. The supplemental information addresses radio and television interference.
5. Amendment to Application Section 18.0, Time Schedule (ARSD 20:10:22:22), a true and correct copy of which is attached as Exhibit E.
 - a. The change reflects the actual filing date of January 17, 2006 for the PUC Route Permit Application dated January 12, 2006.
 - b. The amendment also replaces and supersedes the submission filed November 28, 2006.
6. Supplement to Application Section 23.4.1, a true and correct copy of which is attached as Exhibit F.
 - a. The supplemental information explains the capacity of the transmission lines under extreme wind, ice and wind, and extreme ice conditions.
