Dear Kara:

I am sorry it has taken so long to respond to your letter of November 19, 2007. However, Brookings Municipal Utilities during the past couple of months has been preparing all of the information that is being requested by the Public Utilities Commission.

I have two questions. First of all, is it necessary that a docket be created concerning this matter? In the past both in telecommunications and in electrical as far as annexations are concerned, there never has been a docket created. It would seem to me that we simply file the maps and then they are approved.

Secondly, intend to comply with the Commission's we requests for information but I am wondering under what statute a municipality and a rural electric provider must provide the information you are requesting to the Public Utilities For your review, I am enclosing a copy of a letter that the previous Utilities Manager sent to the Public Utilities Commission on December 7, 1994. Also enclosed is the response from Rolayne Ailts Wiest, the Commission Counsel.

The only statute that I am aware of that requires Public Utility Commission approval is SDCL 49-34A-55 but that section only has to do when a rural electric provider and a municipality or any other service providers make a mutual agreement to revise service territories. I cannot find a statute that says when a municipality has annexed territory and when the municipality and the rural service provider have arrived at an agreement that information needs to be approved by the Public Utilities

Commission. Any guidance you could give me would be greatly appreciated.

Finally, you wrote an email to Paul Melby on Thursday, January 3. At that time, you indicated that you could not locate a map that was sent to the Commission in 1999. I am enclosing a copy of the letter of transmittal from Andy Jensen as well a copy of the map that was actually sent.

Dear Mr. Jensen:

In your letter dated December 7, 1994, you asked whether the Commission needed to formally approve your territorial boundary agreements you filed in July. As I stated in our telephone conversation, when a municipality purchases electric facilities in an area annexed by the municipality pursuant to SDCL 49-34A-50 no formal approval is required by the Commission. The Commission would become involved only if the electric utility and municipality were unable to agree on the price. See SDCL 49-34A-51. Only sales made pursuant to SDCL 49-34A-55 must be approved by the Commission.

We have reviewed your July filing and found that you have complied with the applicable statutes. The Commission has noted the changes on our boundary maps. If you have any further questions, please do not hesitate to contact us.
