The schedule provides the volume of heating oil hedged as of January 1, 2020, and the estimated maximum and minimum annual gain and loss that would be expected to be experienced using the actual price history for the January 2018 through December 2020 period. As of January 1, 2020, MidAmerican Energy Company did not have any open heating oil hedge positions. MidAmerican continues to evaluate heating oil hedging and could hedge heating oil utilizing Intercontinental Exchange futures contracts, financial over-the-counter contracts, or physical fixed price agreements for future periods.
